## Information on toxicological effects

<b>Inhaled</b>	The material is not thought to produce adverse health effects or irritation of the respiratory tract (as classified by EC Directives using animal models). Nevertheless, good hygiene practice requires that exposure be kept to a minimum and that suitable control measures be used in an occupational setting. Inhalation of oil droplets/ aerosols may cause discomfort and may produce chemical pneumonitis.
<b>Ingestion</b>	The material has <b>NOT</b> been classified by EC Directives or other classification systems as "harmful by ingestion". This is because of the lack of corroborating animal or human evidence. The material may still be damaging to the health of the individual, following ingestion, especially where pre-existing organ (e.g liver, kidney) damage is evident. <b>WHITE MINERAL OIL (PETROLEUM)</b>	<p>The materials included in the Lubricating Base Oils category are related from both process and physical-chemical perspectives; The potential toxicity of a specific distillate base oil is inversely related to the severity or extent of processing the oil has undergone, since:</p> <ul style="list-style-type: none"> <li>-The adverse effects of these materials are associated with undesirable components, and</li> <li>-The levels of the undesirable components are inversely related to the degree of processing;</li> <li>-Distillate base oils receiving the same degree or extent of processing will have similar toxicities;</li> <li>-The potential toxicity of <i>residual base oils</i> is independent of the degree of processing the oil receives.</li> <li>-The reproductive and developmental toxicity of the distillate base oils is inversely related to the degree of processing.</li> </ul> <p>The degree of refining influences the carcinogenic potential of the oils.
